EXOSTIV License Server Administration – User’s Guide

Scope

This guide applies to EXOSTIV Dashboard software when used with floating licenses. In such a case, a ‘license server’ must be installed and running to Exostiv Dashboard application lease the floating licenses over the network.

Files

Server execution


File name	Description / Usage
FLicSrv.exe	License server executable – for Windows and Linux.
FLicSrvSvc.exe	License server service – Windows only. The floating license server as a service provides the same set of functionalities as the license server application. The service actually starts the application in background. Linux users should check with their IT manager about how to start the license server (FLicSrv.exe) as a daemon.
FLicSrvSvcStart.bat*	Batch file used to start license server as a service – Windows only.
FLicSrvSvcStop.bat*	Batch file used to stop license server as a service – Windows only.
FLicSrvSvcRestart.bat*	Batch file used to restart license server as a service – Windows only.

* Batch files (.bat) must be executed in a Windows Command Prompt with Administrator privileges.

Configuration & Logging

File name	Description / Usage
FLicSrv.cfg	Only required if you use the floating license server as a service under Windows. Can be optionally used with the floating license server application (GUI). To be placed at the same level as the floating license server executable. Contains the server configuration. If no file is provided, the server uses the previous configuration. If there is no previous configuration, the license server should be set up from the graphical user interface.
ExFLicSrvSvc.html	When logging is enabled in the configuration file, contains the log journal of the floating license server. This file is automatically generated when the logging is enabled in the configuration file. When using the floating license server application (GUI), the log can be found in the GUI Log Window.

Using the license server as a service


For the service mode, the 'FLicSrv.cfg' configuration file must be used (an example is located in the .\documentation\directory from version 1.8.x of Exostiv Dashboard).

(Windows only) : To control the execution of the server as a service, use the following batch file in a **Command Prompt with Administrator Privileges**:


- **FLicSrvSvcStart.bat** : starts the server as a service:


